LIQUID FIRE moved up three wide on the turn, battled through the lane and finished gamely. LING LING QI in the three path on the turn, finished willingly while earning the show. ONE NEAT CAT set the pace, saved ground and responded willingly in the drive then yielded. RIVER NORTH saved ground early, moved out on the turn, raced in the five path into the stretch and lacked a rally. SMOKE'N REVIEW pressed early, saved ground and weakened on the turn. JOHN'S PIC between rivals into the turn, raced near the rail and tired through the lane. CHEROKEE EMPIRE lost the rider at the break. The stewards posted the inquiry sign concerning CHEROKEE EMPIRE prior to declaring the original order of finish official.
