DEFREREST OF ALL stalked to the lane, responded when asked and finished willingly while unable to make up the needed ground late. KAIBAB TRAIL stumbled at the start, chased and lacked the needed stretch response. COURT ORDER saved ground while forwardly placed and lacked the needed late bid. MAN OF LEISURE raced between rivals on the turn and weakened in the drive. LIANA SUSQUEHANA broke in and slow early, moved up and raced between foes into the turn, was near the inside to the lane and tired. BILLICA bumped at the start, saved ground and lacked the needed bid. LITTLE PARKER was out in the strip and lacked a bid while racing greenly. LOOT A KRIS weakened on the turn. LANAVE lacked a response while out in the strip to the turn.
