ALKE JOHN advanced outside on the final turn, raced in the four path entering the stretch and finished gamely to prevail. OPEN OUTCRY three wide early, moved inside and raced up close, bid along the rail in the lane and battled for command then just missed. ALICANTINO set the pace, raced just off the rail into the lane and yielded in the drive. DANCING LOUNGE raced three wide passing the quarter pole and offered a late gain. CAPITAL FELLOW between foes into the clubhouse turn, tracked, chased turning for home and weakened. MR. ESPRESSO raced in the four path turning for home and lacked the needed rally. DELIRIOUS TIDE saved ground and lacked a bid. UNCLE HARRY inside into the far turn, eased out some and lacked a rally. THEMANMYTHNLEGEND raced four wide on the final turn and lacked a bid. BRAVE TIGER four wide into the clubhouse turn, raced up close into the far turn and weakened.
