EMERALD EARRINGS four wide into the clubhouse turn then close up outside, challenged for the lead on the final turn under mild urging, reached the front nearing the quarter pole and drew clear in upper stretch, gradually moved in then responded to pressure and held all rivals safe to the wire. SILMARIL lodged a bid on the final turn, raced between foes nearing the quarter pole and finished gamely outside. GIPSY LIMITS set the early pace, raced just off the inside on the final turn and held on gamely to the end. VICTORY POOL close up into the far turn while just off the inside, saved ground passing the quarter pole and lacked the needed response. CHRUSCIKI trailed while not far back and lacked a rally. FINAL ASSAULT saved ground while an early factor and weakened on the final turn. MY GIRLIE prompted the early issue, raced in a bit close briefly on the final turn, weakened then was eased late and walked off.
