QUPPY saved ground early, raced in the three path turning for home while inside a rival, drifted out some in midstretch then lacked the needed response. AUSTIN'S BELLE outside a foe down the backstretch on the turn, raced in the four path into the stretch and lacked the needed rally. BOMBAY BLUES lacked a rally.
