MOE'S MON pressed the early issue from between rivals, moved to the front on the turn and was rated to the lane then responded when asked to widen. DEUX MILLE lodged a four deep bid nearing the quarter pole and finished well while second best. COASTAL CRIME well placed while saving ground, raced between foes in upper stretch and lacked the needed response. SCATTERING BREEZES broke out some, pressed the early issue three deep and weakened through the lane. ANTHONY SOPRANO hustled through the early stages, saved ground while vying for command and tired through the stretch. TOP VENTURE dropped back nearing the turn. RIVER MOUNT was outrun.
