CAPITALISM AT RISK prompted the issue outside, drifted out into midstretch run then proved best while finishing out in the strip. SUPER NOVA DESERT set the pace inside, drifted out some leaving the furlong grounds and yielded grudgingly. RAVIN IN THE HEAT broke alertly, lodged a three wide bid on the turn and lacked the needed late response. MAGGIE'S BOOTS raced between rivals nearing the quarter pole and lacked the needed rally. ROCK CASTLE COUNTY raced outside turning for home and lacked a rally. FIVE PESOS chased early, raced near the rail on the turn and weakened. CAILIN DEAS chased early, raced inside on the turn and tired.
