SUZANNE'S FRIEND showed the way to the lane and responded to left handed urging and widened then was kept busy until the late stages. RUMMER well placed and three wide into the stretch, was bumped nearing the eighth pole then earned the place. BLAZING CITY chased on the turn, bumped with a rival nearing the furlong marker and weakened late. MALIBU MYSTERY between foes early, raced along the inside turning for home and lacked the needed bid. TURN RED raced four wide on the turn and lacked the needed response. STRIKE DOWN raced near the rail on the turn and lacked a rally. THE DEVIL YOU SAY fractious briefly during the post parade, trailed and lacked a bid. BEARS N THE CREEK chased early inside and weakened.
