REVELATOR brushed at the start and a bit sluggish leaving the gate, raced outside into the clubhouse turn, was four wide entering the far turn and lodged a bid, dueled for command through the lane and proved best. LISTENTOTHEJUNKMAN well placed early, lodged a three wide bid on the final turn and reached the front nearing the five-sixteenths pole, dueled inside the top one through the stretch, drifted some and yielded grudgingly. VOW TO HONOR raced outside and advanced on the last turn then was no match for the top pair while best of the rest. PRIVATE RULES set the early pace and weakened through the lane. CELLA MUFFLER inside to the far turn, raced in the three path turning for home and lacked the needed bid. DEWEST was steadied in a bit tight along the inside on the clubhouse turn, moved off the rail and stalked to the far turn then weakened. FIFTY SIX tracked inside into the far turn and tired. LION UNDER OATH lacked a response.
