SKIPPER TALE was shuffled back on the chute, immediately picked up the chase off the rail, eased five wide leaving the quarter pole and continued in a steady advance to get up the final strides as a result of good handling. LULU'S NUMBER rated with the pace three wide, edged clear into the lane, looked like the winner at the sixteenth pole but was outfinished the final strides. ALOTOFAPPEAL rated with the pace inside, contested the rail through the final turn, dueled into the lane then weakened inside the eighth pole. MORGAN'S WISH rated a short lead two deep and between horses, was shuffled back leaving the quarter pole, stayed boxed on the rail through the top of the lane and finished evenly when clear. APRIL STORM rated off the pace and off the rail, started a four wide drive into the turn, had aim in the upper stretch then flattened out the final furlong. DEVIL'S BRIDE showed no speed while saving ground.
