ANDROMEDA'S STORM between rivals into the far turn, moved to a narrow advantage three wide on the final turn, battled through the lane and was bumped nearing the sixteenth pole then edged clear. RANDI'SAPPROVAL broke slowly and four wide early, raced in the four path again entering the lane, chased and loomed a solid threat, lugged in during the final furlong and bumped with the top one then was no match late. EXHIBIT A stumbled at the start, moved to the front inside between calls nearing the far turn, battled into midstretch and weakened. PEANUTBUTTERBROWN moved to the front on the backstretch, raced just off the inside and was between rivals then tired in the drive. TIGER'S ARGUMENT trailed early, was asked on the final turn and advanced some then lacked the needed stretch response. WHO KNOWS BEST up close early, raced four deep into the far turn and weakened then faded through the lane. NYCONN CAT showed brief foot, gave way after a half then faded.
