LOVELY LUCILLE raced three wide between rivals and finished evenly. SISTER SHOCKEY chased and closed belatedly inside. DEFREREST BURN raced off the pace and made a mild gain inside. BILL'S JERSEY raced three wide into the lane and lacked a rally. ROCK CASTLE COUNTY raced off the pace inside, moved up four wide on the turn and lacked a rally. BEST DECISION bobbled and was bumped at the break, raced off the rail, came four wide into the lane and lacked a rally. CONCORDE'S PASTRY chased two wide and tired. DANCE N RUN raced off the rail and did not factor. CHARGINGTOOMUCH saved ground to no avail. SWAN SONG was bumped at the start, chased inside and faded.
