MAJESTICTROUBADOUR lodged a bid on the final turn and reached the front turning for home then responded gamely in the drive and held to the wire. VERVEITUP five wide into the stretch, came in despite left handed pressure passing the sixteenth pole crowding a rival then finished gamely for the place. BOLD INTENTION raced just off the inside into the lane, raced in tight between foes a sixteenth out then finished willingly. CERTAIN APPEAL pulled early, moved to the three path turning for home, raced between foes in midstretch and chased then needed more. TAPERRIFIC in closest attendance early and just off the rail turning for home, chased inside through the lane and lacked a late response. DREAMY MOMENT lacked the needed bid then was moved outward late to avoid a fallen rider. CLASSIC BROOK sprinted clear early and widened into the backstretch, had little left entering the lane then was eased up late avoiding a spill. METEOR STREAK trailed and lacked a rally then was eased up late avoiding a spill. CHILKOOT TRAIL four wide turning for home, raced in tight inside the sixteenth pole then clipped heels and stumbled unseated the rider. Following a stewards inquiry, VERVEITUP was disqualified from second and placed last for stretch interference.
