HOLY SMOKE raced off the rail, moved up outside on the turn, rallied four wide into the stretch and pulled clear. AIRDROP raced close up inside, saved ground on the far turn, split foes in the two path in upper stretch and finished willingly to earn the place. JOEY WHISPERS was bumped at the start, stalked outside, bid three wide on the far turn, rallied between horses and was outkicked. CALIPARI raced off the pace, saved ground on the turn, angled out in midstretch and rallied mildly. CONCORDE COUNTY vied three wide early, then stalked, came three wide into the lane and lacked a bid. COCODIMAMA vied inside, dug in turning for home and weakened. VIOLATOR was outrun early and gained some ground. SCUDERO vied between rivals early, continued to press outside and tired. ANDROMEDA'S STORM was bumped at the start and outrun. ROARS MORE did not factor. THUNDER OF INDIA was outrun.
