**Footnotes**

BESTCASESCENARIO showed the way to the lane and raced off the rail, drifted out briefly in midstretch then edged away under urging. MALIBU MYSTERY raced along the inside turning for home and finished willingly while second best. HIHOPESMPTYOCKETS raced near the rail on the turn and lacked the needed late response. SINATRA'S DANCER broke out and outside into the turn, raced in the three path into the lane and lacked a late bid. ALLENS PRIZE in tight at the start and four wide passing the three-eighths pole, offered a belated gain. ONE DAY SALE bumped at the start, chased off the inside and weakened in the drive. RAISE A READER came in at the start and steadied off a rival, lacked a rally. BRIGADIER GENERAL chased and tired through the lane. BLAZING CITY saved ground and lacked a bid. MO'S RIVERA chased to the lane, raced five wide into the stretch and tired. RAISE THE CODE was forced in at the start, raced between rivals entering the turn and moved up some then tired.
