Footnotes

QUINCY LEE raced off the pace inside, came four wide into the lane, came in slightly in midstretch, closed gamely outside and prevailed in the final strides. LOVE SHACK (IRE) settled off the rail, bid three wide on the turn, drifted out a bit in midstretch and battled it out gamely with the winner to the wire. SUBPOENA stalked in the two path, bid between foes on the turn and was outfinished. OUR GIN MILL stalked the pace, raced between horses turning for home, continued inside and needed more. I LIKE IT raced between rivals, came three wide into the lane, was in tight between rivals and forced to steady past the furlong marker, then weakened. FASTER was bumped at the start, outrun early and gained ground late. CANDY CAT CAN was bumped at the start, set the pace, duled inside on the far turn and tired. A Jockey's Objection by the rider of I LIKE IT against the winner was dismissed.
