### Footnotes

REBA'S AFFAIR came in some heading into the far turn and drew clear, widened into midstretch then was ridden out. JUST CALL MY NAME saved ground into the far turn, moved out for the drive and closed well late. EASLEY AMUSED vied early inside, was steadied entering the far turn, chased and held a share. SNEAKIN UP three wide on the clubhouse turn, chased and needed more. LATE FOR CLASS raced in the three path into the lane and lacked the needed bid. SKIPPIN N AJUMPIN saved ground and lacked a bid. AURIC GIRL lacked a rally. MARBLEHEAD HARBOR raced near the inside and lacked a bid. FLIRTY GIRTY raced three wide into the far turn and lacked a rally. An objection by the rider of EASLEY AMUSED against the winner for interference entering the far turn was not allowed.
