Footnotes

EVE GISELLE bumped at the start, prompted the early issue outside a rival, moved to the front three deep on the turn, came in into lane then responded well while drawing clear. MEGA HEIR raced in the four path into the lane and finished gamely. MI D' RULER bumped with a rival at the start, set the pace off the rail, raced between foes turning for home and weakened in the drive. D'CATS MEOW in a bit close at the start, moved inside heading into the turn, joined the leaders on the bend, was steadied entering the lane and weakened. HUNKA'S VICTORY in close at the start, trailed and lacked a rally. A claim of foul by the rider of D'CATS MEOW against the winner for interference entering the stretch was not allowed.
