FO FO FO raced off the pace, advanced inside entering the far turn, came three wide into the lane, closed willingly outside and kicked clear. ROJO'S TUNE dueled inside and dug in gamely on the rail to earn the place. CASS tracked inside, bid two wide on the far turn and was outfinished in the stretch. CHARMINGMEGAN raced between rivals, three wide on the far turn, was steadied midway on the turn and rallied mildly. LATE FOR CLASS raced three wide on the first turn, between rivals at the quarter pole and lacked a rally. ANGEL'S VISION was outrun early and failed to rally. EASLEY AMUSED chased three wide and tired. GREEN CREEK raced off the pace, came four wide into the lane and did not factor. BEACH BADGE dueled outside and gave way. SITORA raced far back.
