DANCING LION raced off the pace inside, moved up on the rail around the far turn, rallied outside turning for home and came up second best. FUZZY MUZZLE settled off the rail, moved up three wide on the far turn and lacked a winning bid. JAX MAXX had a three wide trip and failed to rally. IN GOD'S COUNTRY was outrun early, moved up inside and failed to threaten. BOARDING PASS raced three wide early, chased two wide and tired. HERMOSILLO vied outside and faded.
