### Footnotes

CALL ME LOU saved ground, set pressured pace and drew clear in the upper stretch. SPANISH JAZZ pressed the pace to the outside, weakened near the quarter pole and held place. BULL TIME raced five wide early, contended, then rallied four wide and finished well. INQUISITIVE SON saved ground, raced evenly, gained ground in the second turn and showed a mild rally. DELTA COURT raced between rivals early and raced evenly on the rail. ARCTIC CEAL stalked the pace but weakened at the quarter pole and faded in the stretch. LUCK OF THE DAY lacked early speed, raced three wide into the first turn and was no factor. DOUBLE IT was away slowly, trailed and showed little. FAMEQUEST stalked the pace, weakened in the backstretch and gave way steadily.
