TRIAL BY PEERS dueled, outside, led 3rd turn, weakened, held well. BATTLE RIVER stalked pace outside, bid turn three, rallied, outfinished. SEATTLE CYPRESS slow early, stalked pace, evenly, bid upper stretch, hung. THUNDER ON FIRE rail, dueled, weakened backstretch, dropped back.
