CACTUS CUT rail, stalked pace, bid backstretch, flattened out. CRIMINAL OFFENSE dueled, outside weakened stretch, held place. RATTLE THE CAGE outside evenly, close up, rallied 3 wide, gaining, hung. NO MO BAMBINO rail, dueled, weakened, backstretch, dropped back 2nd turn. CANDLESTICK JACK outside, gaining backstretch, weakened 2nd turn. HARLEM no speed, evenly, rallied 4 wide, gaining. TRUCKIN drifted first turn, gained in the backstretch but flattened out. SHANS VICTOR drifted first turn, no factor. STRIKING TIME no speed, through early.
