I RAFFAELLA saved ground, stalked the pace, weakened in the second turn and dropped back. MARRY ME VICKY raced from the rail, stalked the pace evenly and faded in the stretch. SUPERCILIOUS was off slow, trailed and was no threat. FORDY EIGHT CUSH taken back early and was not a factor. SILVER CITY SIZZLE lacked speed and trailed last half of the race.
