**Footnotes**

FRONTIER EXPRESS dueled to the outside of GHOST PIRATE, assumed command late in the second turn and drew clear. CHURCHBRIDGE saved ground, raced evenly, gained ground in the second turn, got through on the rail in the upper stretch, rallied to finish second best. ONENEVERKNOWS raced close up to the outside, rallied three wide into the stretch and finished well. LIGHT OF GOLD entered the first turn three wide, dropped back then rallied three wide and finished well. GHOST PIRATE broke sharply to duel to the inside of FRONTIER EXPRESS BUT weakened in the second turn and faded in the stretch. SIN TORO raced close up on the rail, entered the upper stretch three wide and faded. ROYALTY BOY lacked speed, trailed, gained ground in the second turn but flattened out in the stretch.
