**Footnotes**

ICE GIRL dueled to the outside of SPEEDY GONE SALLY, opened a lead in the third turn, dueled again in the stretch, was headed but came again late to get up at the wire. BANJO BABE was wide early and taken back to stalked the leaders, made a bid for the lead in the upper stretch, dueled, led late but just failed. Following a Steward's inquiry, BANJO BABE was disqualified from second and placed seventh for interference near the quarter pole. SOCORRO COUNTY was slow early, advanced steadily in the third turn, rallied four wide in the stretch and closed the gap. KATHERN'S CAT rushed to contention early, entered the turn three wide, stalked the leaders, was three wide into the stretch and faded. BRAETTA raced evenly on the rail, entered the stretch four wide and finished evenly. TO DREAM AGAIN was wide early, raced evenly, entered the stretch five wide and faded stretch. REGAL VICKY was wide early and was taken back, raced evenly and was no threat. SPEEDY GONE SALLY dueled on the rail with ICE GIRL, weakened at the quarter pole, was in tight after the quarter pole, stumbled and lost the jockey.
