KING JEREMY set pressured pace, led stretch, weakened late, gamely. JAMES LOGAN stalked pace, outside, rallied upper stretch, closed late. STARLIGHT DANCER rail, close up, got through upper stretch, rallied, gaining late. DANCE ME FREE pressed pace, outside, weakened 1/4 pole, flattened out stretch. JUDGE RUCKUS 3 wide first turn, evenly, close up, mild bid, late gain. CHURCHBRIDGE forced out first turn, contended, 3 wide, rallied, gaining. CABIN STABIN slow early, evenly, rallied 3 wide upper stretch, late gain. JOHNNIE ON THE RUN in tight early, taken back, rail, no factor. HERGESHEIMER slow early, drifted first turn, evenly, no threat. TYCOON COUNTY rail, evenly, weakened backstretch, dropped back.
