APPEALING TRIP broke well, vied for the lead from between rivals, dueled in the third turn, rallied and led in mid stretch. WAINWRIGHT saved ground, stalked the pace, dropped back in the backstretch, rallied and closed late. BOONSTOCK vied on the rail, dueled in the third turn but weakened in mid stretch. YO CLAUDIO vied three wide, weakened late in the backstretch and showed a mild rally.
