### Footnotes

DAKOTA WARRIOR ran evenly on the rail, raced evenly, gained ground steadily, rallied into the stretch and closed steadily fro three wide. SPEEDY EYES dueled to the outside, rallied into the upper stretch, led late but was outfinished. CAPPUCHINO GIRL broke sharply, dueled on the rail, weakened in the upper stretch and faded. PANARAMIC SMILE raced close up on the rail, raced evenly, showed a mild rally but faded in the stretch. DASHFORPEACE raced three wide in the first turn, dropped back in the backstretch and made a mild bid. GOLDEN SNITCH lacked early speed, saved ground, raced evenly and showed a mild bid. RITZY MON raced four wide in the first turn, stalked the pace but weakened near the quarter pole and dropped back. DREAMING DANCER saved ground, stalked the pace evenly but weakened in the second turn, drifted and gave way.
