GLAD'S AND ROSE'S dueled to the outside, opened a lead after the pole, rallied and drew clear in the stretch. ROYAL TIARA chased the lead on the rail, rallied in the upper stretch and closed on place. CLASSIC CONNECTION broke sharply, dueled on the rail, weakened in the second turn and faded in the stretch. GHOSTLY GLITTER raced evenly to the outside, gained ground in the backstretch, rallied four wide and finished evenly. FEISTY DEVIL ran unevenly at the start, SAVED GROUND, rallied and passed tiring rivals. RAYITO DE LUNA raced three wide in the first turn, trailed and was no factor. DOCTOR M J chased the lead on the rail, weakened after the quarter pole and gave way. The rider on DOCTOR M claimed foul on GLAD'S AND ROSE'S for interference entering the first turn. The claim of foul was not allowed.
