OBLIGATORY GLORY dueled on the the rail rallied upper stretch, held well. CARLOTTA DEL SOL broke well, rail, steady gain, rallied stretch, closed well. NOTICE THE WAVE 3 wide early, chased, weakened, rallied 3 wide, finished well. T AND T'S JET dueled outside, weakened 2nd turn, rallied, faded stretch. EARLY NEWS drifted first turn, evenly, outside, rallied 4 wide, evenly. KESTNER slow early, evenly, no factor. SHADOWA'S WAY no speed, trailed, no factor. JAUNICO slow early, gave way, trailed.
