Supplementary nominations may be made by the closing time of entries at a fee of \$2,000 which qualifies to start with \$75,000 Guaranteed of which 60% to the Owner of the winner, 20% to second, 10% to third, 5% to fourth, 3% to fifth and 2% to be divided equally between remaining starters. WEIGHTS: 122 lbs. Non-winners of \$60,000 in 2011, allowed 3 lbs.; \$35,000 since September 13, 2011, allowed 5 lbs.; \$25,000 since November 13th, allowed 7 lbs. (Maiden and Claiming races not considered). In Allowance Stakes starting preference will be given to horses that have accumulated the highest earnings, excluding money won in restricted races. Starters to be named through the entry box by the usual time of closing. The Owner of the winner to receive a trophy. Closed Friday, January 6, 2012 with 23 nominees.

COLOR ME BLUE bit tight at the start, unhurried in the early going, moved closer in traffic turning for home, split foes nearing the furlong marker, gained the advantage and proved game in the waning strides to prove narrowly best. TWICE THE APPEAL settled off the pace, moved out, four wide turning for home when advancing, challenged late, outkicked in the final strides outside, the winner. IT HAPPENED AGAIN lacked speed, traffic, closer in the second turn, lacked room in upper stretch, switched to the outside soon after, staged a modest late rally to finish up best of the rest. RACING BRAN within striking distance early, moved up to challenge between foes in the second turn, weakened in the drive. ENCLOSURE in tight at the start, lost an iron early when in traffic, got out slightly into the first turn, stalked, challenged briefly in the second turn, also faltered in the drive. BALLYJAMESDUFF four wide trip most of the way, lacked a kick in the drive. BONAROO pressed the leader for five furlongs, gave way. RICHMOND narrowly set the pace while attempting to rate early, gave way when headed.
