WEIGHTS: 122 lbs. Non-winners of \$35,000 since September 16 allowed 3 lbs.; \$25,000 since October 16 allowed 5 lbs.; \$20,000 since November 16 allowed 8 lbs. (Maiden and Claiming races not considered). In Allowance Stakes starting preference will be given to horses that have accumulated the highest earnings, excluding money won in restricted races. Starters to be named through the entry box by the usual time of closing. The Owner of the winner to receive a trophy. Nominations closed Tuesday, January 12, 2010 with 19 nominees.

### Footnotes

NORTHERN BELLE moved out in the strip after the start, came five wide out of the turn, set down, late bid, just up final strides. ONE SMOKIN' LADY broke sharp, soon got clear, set the pace, drifted out inside the furlong grounds to impede AUSPICIOUS, responded when challenged late, nipped at the wire. FOLLOWING A STEWARDS' INQUIRY REGARDING THE STRETCH RUN, ONE SMOKIN' LADY WAS DISQUALIFIED AND PLACED FOURTH. SYRIANA'S SONG lacked speed, came on the outside for the drive, displayed some belated interest down the middle of the strip. AUSPICIOUS closest to the leader for a half, impeded when that foe came out with a furlong remaining, flattened out. BREATHTAKINGBREEZE within striking distance for a half, lacked a response in the drive. VALID CODE was finished early.
