BACCHANTE last to leave, raced far back early, angled out far turn, outside bid, edged clear under steady handling. PROPER QUICK lacked speed inside, rallied, clearly second best. ELEGANTLY QUIET forwardly placed and inside, continued to save ground into the second turn, lacked a winning response in the drive. SHE'S ABOVE DA LAW second flight off the inside, stalked, bid turning for home, hung. MISS ECTON STUFF three wide far turn, lacked a serious kick in the drive. GOLDEN PULPIT in the second group while four wide into the far turn, came up empty in the drive. LOST ACCOUNT failed to menace. URANIUM within striking distance three wide, tired in the drive. MINE THAT BREW remained back. FOURTEEN DREAMS dueled up front off the inside, gave way in the drive. SUN RAINBOW STAR dueled up front, cleared to the inside, alternated up front, stopped. DENSE FOG OBSCURED THE INTERNAL POINTS OF CALL.
