**Footnotes**

TIMELY PURSUIT outrun in the early going, came four wide when beginning to rally out of the final turn, closed willingly to be in time. LAKE CREEK narrowly set the pace along the inside while attempting to rate, got clear before a half, continued to show the way until very late and proved stubborn to the end while drifting a bit. COMPETENT rated behind the pace toward but not on the inside, moved out to be five wide turning for home, lost some ground to the runner up as a result, set down and closed well to miss the place. DUCA closest to the pace, bid between foes stretch, not enough late. JACK'S WORK four wide in the first turn when off the pace, ranged up to challenge three wide turning for home, vied past the furlong marker, hung in the late going. LONGSHOT WARRIOR forwardly placed toward the inside, shuffled back in the second turn, moved out, appeared to be trying to close the gap late on the first flight. HOT DIGGITY DOG settled off the pace, gave way in the second turn, finished up well back. GRAN TORINE last to leave, raced sluggishly, distanced after losing contact with the field.
