**Footnotes**

SOURIS settled off the pace, enjoyed a golden trip along the inside out of the turn, rail bid, roused, drove clear. SALTWATER RUNNER lacked early foot, lost considerable ground to the winner with a five wide trip out of the turn, rallied for the place. SOUTHERN SURPRISE prompted the pace, had little left for the late going, narrowly held the show. INJUSTICE four wide while off the pace turning for home, bit tight midstretch, finished evenly. THERMAL ABLASION in traffic through much of the stretch run, lacked a late kick. JOSH'S MADELYN last away, void of speed, did not fire. SHE'S A REBEL TOO sprinted clear soon after the start along the inside, gave way when headed in upper stretch. KATESTORMEDTHEBIRD was through early.
