WARREN'S DOVE with the pace from the start, vied off the inside into the turn, long drive, proved determined to narrowly prevail while between horses at the wire. BLUEGRASS TYPE vied up front early while between rivals, dueled inside the winner through the turn, continued in spirited fashion to the wire, outkicked in the final strides, gained the nod for the place. FLASHY GREEN bumped at the start, raced back off the pace, five wide through the turn, roused for the drive, finished with good late energy to be rapidly getting to the top two in the final yards. WILSON RIVER off the pace, dropped inside to save some ground through the turn, angled out for the drive, closed the gap some late, between rivals at the wire. THE FOURTH ESTATE briefly with the early pace inside, continued forwardly placed through the turn, had little left for the drive. DICTUM void of early foot, six wide out of the turn, improved position down

the middle part of the strip. STONE HARBOUR went evenly in lacking a late bid. PRACTICE TEE well back, passed tiring foes. DRAGON HEART broke out, bumped, remained back throughout. NORTHERN CHOICE raced in mid pack early, faded in the drive. SOUTHERN OCEAN toward the front early, began a steady retreat before a half. KEEPINONESTEPAHEAD off slowly, trailed throughout.
