EVENANANGELCANRUN asked early along the inside, moved out midway on the turn, challenged outside the leader, wore that rival down under firm handling. SUSPECTING FIRE broke out but alertly, soon got clear, showed the way into the lane, responded when challenged by the winner, gave ground grudgingly to that rival the final furlong while drifting out a bit late. ME 'N MY SHADOW broke slowly, moved up steadily, closest to the top pair turning for home, flattened out a bit the final furlong. R GOLD CASE settled off the pace and the inside, one paced three wide, continued evenly to the wire. PAM'S LUC fractious post parade, fell quickly back after breaking in good order, well back early, three wide turning for home, late interest the interest had been decided. GUSKA MON SHOES steadied at the start, trailed well back, passed tiring foes. GIMME NO BULL closest to the runner up early, gave way in the turn. MANE MISSION wide trip, no interest in the drive. STORMY TRUTH fractious while loading, not a threat. DESTINY GAYLE tired in the drive. WHACHADONFOMELATLY was finished early. AFLEET DESPERADO raced in midpack early, steadily faded.
