SOPHANDA asked to run in the early going toward the inside, got clear into the turn, continued to be clear stretch, caught late, gained nod. HIGH BROW HONEY forwardly placed toward the inside, moved off the inside, late bid, led a jump out, missed nod. WILD ORATION lacked speed, came four wide out of the turn, closing gap on the top two late. SING A FEW BARS off the pace and the inside, three wide late turn, dropped inside nearing the furlong marker when improving slightly, flattened out and was going evenly at the end. BUZZ MY BELL forwardly placed and outside, had little left. OUTRAGEOUS settled toward the inside, made little impact in the drive. LOOKSLIKELOVE last away, trailed for a half, swung out to be seven wide exiting the turn, passed tiring foes well out in the strip. BAQUERO'S SLEWGIRL closest to the winner for a half off the inside, gave way in the drive. ABELIA failed to menace while five wide through most of the turn. HATTIE MAE was through early. NICKELODEON LADY was always outrun. ASK AUNT AMBER steadily faded.
