

WILD REZONUTION forwardly placed for a half, tired a bit, drifted stretch. PILFER well back for a half, came six wide into the stretch, no late gain. PRETTY GIRL SLEW failed to respond in the drive. ELLS EDITOR tired from early efforts. FOREST BO K set the pace for a half, stopped.
