Footnotes

INDULGE ME behind the early pace, moved closer three wide turning for home, challenged late, proved narrowly best under brisk handling while between foes under the wire. LEXS IMAGE last to leave, steered out for room when straightened for home, finished willingly to be closing the gap on the winner late. RUN THE COURT close from the start off the inside, pressed into the lane, put a head in front nearing the furlong grounds, could not contain the top two late. SHINING GRACE asked along early, could not keep up, advanced out of the turn toward the inside, modest late gain. EMERALD CREEK steadied at the start, raced well back, saved some ground into the lane, made a late run up the rail. RED DEVIL GAL narrowly set the early pace, briefly got clear into the turn, vied into the lane, faltered late. ANAVAE lacked speed, raced well back, picked off some tiring rivals well out in the strip, never a threat. DIAN FOR A MILLION lacked speed while racing outside, failed to muster a rally. EMILY WILL void of speed, passed tiring rivals. PARADISE DREAMS steadily faded. AMBER'S PROM toward the front early while well wide, tired. ILE ST. SARA RAE forwardly placed for a half, stopped.
