PONI COLADA void of early foot, began to move in the far turn, rallied five wide into the lane, was fully extended late to narrowly prevail. SARAH'S MAN cleared early with minimal effort, set the pace along the inside, headed into lane, regained the lead, responded when challenged by the winner late, held on gamely. ROMAN SILVER chased the runner up outside that one, moved to challenge, briefly put a head in front upper stretch, outkicked by the top two in the late going. DEPUTY SREVA lacked speed, came four wide out of the final turn, roused, finished willingly to improve position late while widest. SCORING SPREE well back, raced along the rail throughout, also improved a bit late. MR. PURSUIT within striking distance, came up empty in the drive. MINIMAST lacked a late bid. PERTINENT forwardly placed, staged a steady retreat.
