Footnotes

BUGGS within striking distance, asked along into the lane, split foes nearing the furlong marker, lugged in a furlong out, repulsed a bid from the runner up and dug in late in game fashion. GORDON DRIVE slight bother at the start, raced back, five wide out of the turn, lodged a bid midstretch, hung+. NOLAN'S REVENGE bumped at the start, raced three out to four wide in the turn, staged a mild rally to be clear of the others. SEQUOIA STORM bumped start, recovered and moved up to vie up front closest to the inside, weakened. ROCKET SHIP broke sharp, set or forced the pace off the inside, faltered. NO CHARGEBACK settled off the pace, moved a bit closer three wide late in the turn, flattened out. SIXPAKOFTHUNDER went evenly paced while off the inside. HOWDY DOODY TIME second flight outside, mild bid four wide turning for home, weakened in the drive. PAIN TOLERANCE lacked speed, never menaced. HOLY BULLHIVE remained back throughout. MR. BARRON last away, trailed most of the way. BARN STORMER steadily retreated.
