QUIET MAN off the pace, began to move after a half, advanced into contention four wide in the second turn, gained the advantage and drove strongly clear in the drive. GO TIGER JACK off the pace, waited in traffic late in the second turn, moved out for room when straightened for home, late run to pick up the place, no threat to the winner. DOUBLE RAH RAH broke on top, narrowly set the pace toward the inside while in hand, continued to show the way through the second turn, also proved no match for the winner, caught late for the show while between horses at the wire. SALSA'S RETURN settled off the pace, in traffic while waiting for room late in the second turn, 4w into lane, modest close, traffic again late. SOUTHERN PARKWAY last away, trailed, seven wide when lodging a mild rally turning for home, improved position. RED WINGS settled off the pace, lacked a late kick. ACAFFELLA four wide in the first turn, moved closer before a half, gave way in the drive. FORGOTTEN KNOT never menaced. JACK N JOHN lacked speed, failed to rally. YOU'RE JOKING duelled early under restraint, asked, stopped in the drive. DIPSY DREW mid pack, gave way, eased stretch, walked off.
