WINNER TO BE last to leave, lacked speed, came on the inside, set down, finished willingly to be clear for the place. LACEY OFFICER brushed at the start, off the pace, advanced three wide through the turn, along for the show, no match for the top two. KIT CARSON closest to the winner while in hand, failed to respond when asked for the drive, weakened late, caught for show. GRAND ILLUMINATION back off the pace, improved a bit while five wide into the lane, went evenly in the drive. MISSISSIPPI MARTINI brushed at the start, never a threat. BRINKS BABY within striking distance, retreated.
