MALORIE'S FIRST away in good order, chased the leader through the turn, engaged that same foe from the outside into the lane, long drive, drifted, fully extended. GINGER'S VALENTINE broke outwardly but sharp, soon got well clear, responded when the winner came alongside upper stretch, proved stubborn til the end. TALE OF UTOPIA forwardly placed well off the inside, three wide into the lane, no match for the top two in the drive, lasted for the show. LITTLEBITCRANKY well back off the pace, four out to five wide in the turn, angled in a bit for the drive, improved position. MOTOKIKS DANCER lacked speed, moved out a bit for the drive, managed little in the way of a late bid. GLOWING REVIEW well back off the pace for a half, came three wide out of the turn, steered out to be widest in the drive, also improved a bit. LILA GRACE steadied at the start to be last away, trailed early, managed a modest amount of late interest in passing tiring rivals. CACTUSA raced toward the front in the early going, retreated through the stretch. GENIE M bothered then checked up at the break, moved up to race in midpack and was never dangerous. MY DADDY'S JEWEL came in just after the start, raced within striking distance early, steadily faded after a half. TIDAL PLAIN was never a factor. DARE TO BE A SAINT was always outrun.
