HES A CAT asked early in moving up inside to clear, shrugged off DISEMBARK turning for home, remained clear once again through the lane under steady handling. MOWGLI'S DANCE raced in midpack early, moved closer along the rail late in the turn, proved no match for the winner in the drive, second best. DISEMBARK closest to the winner off the inside, roused late in the turn, briefly closer, could not keep up in the drive, caught late for the place. R GOLD CASE within striking distance outside, lacked a closing response outside, went evenly in the drive. SEVENTY WEST broke to the inside, steadied, raced back off the pace, steadied again toward the inside early turn, moved out five wide late in the turn brushing with SPITSHINE, displayed some late interest down the middle part of the strip. CODY LAW went one paced throughout while off the inside. CASANOVA COWBOY saved ground to no avail. SLICKROCK ROAD broke out, bumped, straightened to race within striking distance for a quarter, gave way into the far turn, came back to pass a couple of tiring foes late while never a threat. ROMEO ROMEO roughed at the start, raced well back off the pace, five wide into the lane, no rally. SPITSHINE void of speed in trailing for a half, carried out, brushed six wide into the lane, remained back. MANE MISSION forwardly placed early, tired while four wide. DEMONS HERE was outrun.
