Footnotes

KINETIC MOTION broke alertly, dueled up front off the inside, shook clear into the stretch, enough left to hold the runner up safe late. SILVER WAR behind the pace, raced in some traffic upper stretch, angled out a bit, dropped inside late, finished willingly. WINNER'S STORY void of early foot, four wide late in the turn, traffic stretch, angled in, willingly. NATIONAL PARK back off the early pace, five wide out of the turn, brushed nearing the furlong marker, displayed some late interest while widest of the second flight at the wire. THE ELEVATOR forwardly placed three wide, weakened the final furlong while in some traffic. COLTER STONE broke to the inside, dueled inside the winner, weakened in the drive. CHESAPEAKE BAY lacked early foot, toward the inside and in some traffic turning for home, steadied when lacking room a furlong out, evenly after recovering. SEEKING THE LEAD five wide late in the turn, failed to rally. DIAMOND LAD settled off the pace, traffic out of the turn, brushed when tiring, continued to back up. TRIPLE AXEL off the pace, staged a middle move five then four wide through the turn, hung in the drive. ADVANCED SIGNS outrun three wide.
