Footnotes

RUN THE COURT prominent from the start outside, four wide into the turn, briefly dueled, shook clear, kept to task in the drive. PRIMETIME KISS sandwiched start, raced back off the inside, came five wide turning for home, rallied willingly for the place, no match for the winner. GRAY LADY PARTEE in the second flight early while between rivals, closer four wide through the turn, also proved no match for the winner in the drive, caught late for the place. PARIS LUC fractious gate, vied up front in the early going while closest to the inside, fell back in the turn, evenly through the stretch. FUNINTHESTORM vied up front off the inside, had little left for the drive. SWEET RUBY KATE within striking distance while between foes early, fell back turn, no response in the drive. BIT OF BARBED WIRE devoid of early foot in trailing early, found best stride too late. STAR SUSPECT bobbled, broke in, moved up to race in mid pack for a half, no kick in the drive. CELEBRITY STORM bothered at the start, remained back. MI IRIS off slowly, was never close. FERGI WENTACOURTIN wide trip, outrun. MORLUC'S GIRL tired from early efforts.
