KATHLEEN bothered, pushed out start, behind the pace inside, asked along midway on the bend, steadied, dropped toward the inside for room into the stretch, split foes, powered well clear. SHINING GRACE forwardly placed from the start, dueled through the turn while off the inside, continued to vie past the furlong marker, no match for the winner, second best. ATTA GIRL BOO BOO lacked early foot, remained back early in the turn, asked for some run while being swung out five wide turning for home, late run to be clear for the show. ANGELIC HANNAH bumped soundly at the start, well back, improved inside and through some traffic. T R'S HOPE narrowly showed the way early, dueled through the turn, weakened when headed just outside the furlong marker. ILE ST. COURTNEY broke out, bothering outer foes, vied closest to the inside, began to fade early in the turn. DONNA slow to start, improved position while not a serious threat. SISTER BROWN stumbled at the start, made little impact. SHESASUSPECT within striking distance for a half, gave way in the drive. MY DISTRICT bothered at the start, raced in midpack for a half three wide then tired in the drive. SARAH'S SPLENDOR bumped, bobbed at the start, four wide in the turn, tired. I'VE GOT A KICK never close, trailed home.
